Abstract

This study explored the potential of Michael Jackson's iconic song, "Heal the World," to serve as an effective advocacy tool for peace between Palestine and Israel. Released in 1991, the song's universal message of love, unity, and collective responsibility transcends geopolitical boundaries, offering a shared vision for a harmonious future. In the context of the enduring conflict, the song's call for global harmony resonates profoundly, offering a shared vision for a better future. For this study, a qualitative research methodology known as "desk research" or "secondary research" was employed. This approach involves

the collection and synthesis of information from various written and digital sources, such as books, articles, reports, databases, and other publicly available materials. Introduction

This universal language of music has been employed as a powerful tool, capable of bridging divides, healing wounds, and igniting movements for positive transformation (Goldstein, 2016). connect on a profound emotional level, transcending the limitations of language or ideology (Nixon, 2021). Beyond its emotional resonance, music has been instrumental in galvanising collective action and advocating change. Anthems of protest and calls for justice have echoed through the streets of countless nations, providing a unifying soundtrack for movements dedicated to social progress (Myrick, 2021). From the Civil Rights era in the United States, where songs like "We Shall Overcome" became anthems of hope and resilience, to the anti-apartheid struggle in South Africa, where music played a pivotal role in mobilising communities, music has demonstrated its potential as a force for socio-political transformation (Jaftha, 2021).

Moreover, music has often served as a platform for marginalised voices to be heard. It has provided a stage for artistes to express their perspectives, challenge established norms, and shed light on the injustices faced by their communities (Mahlasela, 2020). Through lyrics that tell stories of struggle, resilience, and hope, musicians have amplified the voices of the disenfranchised, using their artistry to shine a spotlight on issues that demand attention and action. In doing so, they have empowered listeners to engage with the realities of others, fostering empathy and a deeper understanding of the complexities of social issues. Additionally, music has been an invaluable tool for cultural diplomacy and cross-cultural understanding. Through the exchange of musical traditions and performances, individuals from different parts of the world have found common ground, celebrating the richness and diversity of global cultures (McGrath & Brennan, 2020). Collaborations between artistes of different backgrounds have led to the creation of transcendent works of art that reflect the shared aspirations of humanity. These musical dialogues serve as a testament to the potential for music to build bridges of understanding and forge connections between communities (McGrath & Brennan, 2020; Myrick, 2021). In essence, music's capacity to serve as a medium for reconciliation, peace-building, and socio-political change is a testament to its enduring power and significance in the human experience. It transcends boundaries, unites hearts, and provides a voice for those who may otherwise go unheard. Therefore, the ongoing conflict between Palestine and Israel has cast a long shadow over international relations, underscoring the urgent need for avenues of reconciliation and peacebuilding. In times of unprecedented turmoil, the potential for art and music to transcend political boundaries and serve as catalysts for a positive change becomes increasingly evident.

It is prudent to mention that the significance of music as a medium for socio-political change has been well-documented in the academic sphere. Numerous studies have examined the impact of music on shaping collective consciousness, fostering empathy, and promoting activism (Condon, 2017; Feld, 1984; Riggio, 2010). Additionally, scholars have explored the role of artistes as advocates for peace and social justice, with a focus on their influence on public opinion and policymaking (Bresler, 2013; Bakan et al., 2012). However, the specific application of a renowned song like "Heal the World" in the context of the Palestine-Israel conflict remains an underexplored area within the existing literature. Despite the extensive body of work on the impact of music on social change, there is a noticeable dearth of research addressing the potential of "Heal the World" as a tool for peace advocacy in the specific context of the Palestine-Israel conflict. The available literature predominantly centres on broader discussions of music's capacity to inspire social transformation, with limited attention paid to the potential application of a specific song in the resolution of a deeply entrenched geopolitical conflict (Mwambari, 2020; Ezeani, 2022; Ocheing, 2022). Furthermore, there is a need for a nuanced examination of the cultural, historical, and political contexts within Palestine and Israel to understand how the song's message may be received and interpreted in these distinct environments.

The motivation behind this study arises from a deep-seated belief in the power of art and music to bridge divides and foster understanding. In the face of an ongoing conflict that has far-reaching consequences, the potential for a universally acclaimed song like "Heal the World" to inspire collective action and empathy is both compelling and timely. By undertaking this research, we aspire to contribute to the discourse on music's role in peacebuilding and to offer a novel perspective on how art can serve as a catalyst for change in even the most entrenched conflicts. In the subsequent sections, this study will delve into a comprehensive analysis of the song's themes, its potential impact on diverse audiences in Palestine and Israel, and the challenges and opportunities inherent in utilising "Heal the World" as a tool for peace advocacy in this specific geopolitical context. To achieve this set goal, the following research questions were developed to guide this study:

- a) How does the song "Heal the World" resonate with audiences in Palestine and Israel amidst the ongoing conflict?
- b) What are the key cultural and political factors that influence the reception and interpretation of "Heal the World" in Palestine and

Israel, and how do they shape its potential as an advocacy tool for peace?

- c) What are the practical strategies and considerations for effectively utilising "Heal the World" as an advocacy tool to promote peace and harmony between Palestine and Israel?

Theoretical Framework

The theoretical framework employed in this study, Conflict Transformation and Peacebuilding, draws from the rich tradition of peace studies and conflict resolution theory, particularly outlined by John Paul Lederach in his seminal work "Building Peace: Sustainable Reconciliation in Divided Societies" (1997). This framework provides a comprehensive approach to addressing entrenched conflicts, emphasising the need for a multidimensional understanding of conflict dynamics. As noted by Hassanein (2023), Conflict Transformation and Peacebuilding underscores the importance of considering not only overt violence but also the underlying structural, cultural, and psychological factors contributing to prolonged disputes.

In the context of the Palestine-Israel conflict, the application of Conflict Transformation and Peacebuilding is particularly pertinent. This conflict's complexity necessitates a multifaceted understanding and a commitment to sustainable solutions (Houghton & Houghton, 2024). Through this lens, various actors, including artistes and musicians, are recognised for their role in shaping perceptions, fostering empathy, and catalysing healing. Artistes and musicians, as cultural influencers, possess the capacity to convey complex emotions and challenge established narratives, as highlighted in the transformative potential of "Heal the World".

"Heal the World" serves as a poignant message of unity and compassion, transcending boundaries of nationality and ideology. Through its evocative lyrics and melody, the song prompts reflection on individual roles in fostering peace. Furthermore, it provides a platform for dialogue and reconciliation, inviting individuals from both sides of the conflict to engage in collective reflection on shared aspirations for peace (Houghton & Houghton, 2024).

Beyond its immediate emotional impact, "Heal the World" contributes to broader societal shifts, influencing attitudes, perceptions, and behaviours related to the conflict. By challenging entrenched divisions and offering an alternative narrative rooted in compassion and

cooperation, the song aligns with the goals of Conflict Transformation and Peacebuilding (Olsson & Moore, 2024). The Conflict Transformation and Peacebuilding framework offers a valuable lens for understanding the role of "Heal the World" in the Palestine-Israel conflict. By recognising the complexity of conflicts and advocating holistic, multidimensional approaches, this framework underscores the potential of art, particularly music, as a powerful tool for promoting understanding, empathy, and healing. Methodology

For this study, a qualitative research methodology known as "desk research" or "secondary research" was employed.
